

TYPAR® LIMITED WARRANTY FOR RESIDENTIAL APPLICATIONS

The installation of Fiberweb™ Typar® Housewrap, Typar® Metrowrap™, Typar® Flex Flashing, Typar® Flashing RA™, Typar® Flashing BA™, and Typar® Construction Tape (collectively, the “Typar Products”) on your Residence (as hereinafter defined) entitles you to the protection provided by the Typar Limited Warranty for Residential Applications.

Limited Lifetime Warranty. Fiberweb, Inc. (“Fiberweb”) warrants that each Typar Product will perform to its published specifications if installed on a Residence in strict compliance with published product installation procedures, accepted industry standards and applicable building codes in a properly constructed and designed wall system. For the lifetime of the Residence, if a Typar Product fails to perform to its applicable, published product specifications, Fiberweb shall, in its sole discretion, either replace or reimburse to an Owner (as hereinafter defined) of the Residence the original purchase price of such failed Typar Product.

Additional Typar® Weather Protection System Limited Warranty. If Typar Products are installed for the entire building envelope of a Residence (the “Typar® Weather Protection System”) in strict compliance with published product installation procedures, accepted industry standards and applicable building codes in a properly constructed and designed wall system, and a Typar Product fails to perform according to its applicable, published product specifications during the ten (10) year period after installation of the Typar® Weather Protection System, Fiberweb shall, in addition to the replacement of or reimbursement for the cost of the Typar Products, compensate an Owner for reasonable construction costs (labor and materials) necessary to repair damage to the Residence caused solely by the failure of such Typar Product.

Definition of Residence. As used in this Limited Warranty, the term “Residence” means a detached single-family or two-family dwelling.

How to make a warranty claim. All claims under this Limited Warranty must be made promptly in writing to Fiberweb, Inc., 70 Old Hickory Blvd., Old Hickory, Tennessee 37138, Attention: Technical Manager. Acceptable validation, in Fiberweb’s sole discretion, of purchase date and price, e.g., a letter of invoice from builder or building material supply company, must be included with all written claims. If Fiberweb determines that an investigation of a claim is necessary, the claimant must permit a Fiberweb representative to access and view the Residence specified in the claim and to take photographs and samples, as may be necessary.

Limitations. This Limited Warranty is the only warranty made by Fiberweb with respect to the Typar Products installed on a Residence and is your SOLE AND EXCLUSIVE remedy under tort, warranty, contract or other applicable law. This Limited Warranty is void if any Typar Product has been subject to misuse, mishandling, misapplication, neglect, improper maintenance, accident, modification, adjustment, repair damage, or improper installation.

This Limited Warranty is transferable from the original owner only to the first subsequent owner of the Residence on which a Typar Product was originally installed (an “Owner”). Any first subsequent owner must notify Fiberweb of the transfer in writing at the above address within thirty (30) days of the transfer and such notice must include the address of the Residence.

EXCEPT FOR THE ABOVE LIMITED WARRANTY, FIBERWEB MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AND DISCLAIMS ALL OTHER WARRANTIES, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

OTHER THAN ITS OBLIGATIONS UNDER THE LIMITED WARRANTY SET OUT ABOVE, IN NO EVENT SHALL FIBERWEB BE LIABLE TO ANY PERSON OR ENTITY FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, PUNITIVE, EXEMPLARY OR EXPECTATION DAMAGES OF ANY KIND ARISING OUT, RELATED TO OR IN CONNECTION WITH THE PRODUCTS, INCLUDING, BUT NOT LIMITED TO, LOST PROFITS OR REVENUE, LOSS OF USE, PERSONAL INJURY OR DAMAGE TO PROPERTY.

This Limited Warranty applies to Typar Products installed on a Residence in the United States of America, its territories and Canada on or after January 1, 2010. This Limited Warranty does not apply to Typar Products used in commercial or multi-family applications.
